1. Full rental will be paid 75 days prior to boarding or my reservation will be cancelled and my deposit will be forfeited. Upon payment of full rental, the deposit becomes the security deposit and will be refunded by CHECK, providing the boat is returned clean, undamaged, and with inventory intact. No gasoline may be charged against the deposit and NO CASH will be refunded. A minimum cleaning fee of \$100 will be charged for all boats returned unclean. A late charge of \$100 per hour or any part of an hour will be charged for late returns.

2. **All cancellations must be in writing.**

- Any cancellation, which is, received *90 or more days* prior to the scheduled boarding date, will result in a refund of your booking deposit, less a \$375 service charge, per ski boat.
- Any cancellation received *between 75-90 days* to the scheduled boarding date will result in a loss of your entire deposit.
- Any cancellation received *less than 75 days* prior to the scheduled boarding date will result in loss of your entire deposit and rental fees. If the houseboat(s) is/are re-rented, your payment(s), less a \$750 service charge per ski boat, will be refunded.

***We regret we cannot make exception to this policy for personal emergencies and deposit may not be rolled from a cancellation year.***

3. **All changes must be in writing.**

- Reservation changes made *90 or more days* prior to the scheduled boarding date will be processed upon payment of a \$375 change fee per ski boat.
- Reservation changes made *less than 90 days* prior to the scheduled boarding date will be processed upon payment of a \$750 change fee per ski boat.
